REPORT ON THE OPINION POLL

At the initiative of the Governing Board, an opinion survey was published on the EUC website in order to gain first-hand knowledge of residents' demands and needs.

The question was: What are the three most important needs to be addressed in Costa Esuri? In addition, there was a section for comments.

The survey was open from 5 July to 19 August 2024, using a Google form. The survey as displayed is included as Annex 1.

DETAILS OF RESPONSES

For more detail, a summary table of all questions, answers and comments is included as Annex II. The following data are highlighted.

A total of 53 overall valid responses were received, as well as 27 comments. Thus, taking into account that each response could contain up to three ordered requirements and one comment, **a total of 186 responses were received.**

Regarding the **needs** for Costa Esuri, 159 replies were received, i.e. 53 for each need. The details are as follows:

- **The first need** with the most responses (11) related to the improvement and increase of public transport, as well as the construction of a bicycle lane.
- **As the second** most frequently mentioned need (15), he suggested an increase in leisure facilities, restaurants and sports areas.
- **The third need** with the highest number of responses (11) concerned the execution of the guarantees by the Ayamonte Town Council..

Totaling the responses relating to the needs of urbanisation (159), the three most frequently repeated responses were:

- Commercial / leisure / sports areas: 30 (18.87%).
- Improvements to the access road, asphaltting and lighting: 21 (13.21%).
- Improving and increasing public transport / cycle paths: 17 (10.69%).

In terms of the comments received, 27 in total, one third of them were about the need to improve quota and tax management, and another third coincided with the three needs with the highest number of responses, as indicated in the previous paragraph.

However, taking into account both the responses to the needs and the comments, i.e. 186 replies, the issues that received **more than 20% of the responses were:**

It should be noted that of the nine needs indicated, most of them are the responsibility of bodies outside the EUC Costa Esuri, with the Ayamonte Town Council being responsible for the vast majority. The same applies to the rest of the needs indicated by the respondents, which can be consulted in Annex II.

FORTHCOMING ACTIONS BY THE EUC GOVERNING COUNCIL

In view of the responses obtained and the needs prioritised by the owners, **the Ayamonte Town Council will be informed of those needs that correspond to its competence**, such as those related to road improvements, public transport, collection management, enforcement of guarantees, and security.

However, **it is up to the EUC to repair the pavements**, and to exert the necessary pressure on the Consistory to ensure that these demands are taken into account and solved as soon as possible. We will make every effort to do so.
